CHARGE

Karen Jane Devlin SHANLEY, a dental nurse, National Certificate NEBDN 2010, is summoned to appear before the Professional Conduct Committee on 24 March for an inquiry into the following charge:

"That being a registered dental care professional:

- 1. On 27/11/2013, you were convicted at Edinburgh Sheriff Court of the following offences:
 - a. Send a non-sexual offensive/indecent/obscene/menacing message by means of public electronic communications contrary to s.127(1)(a) of the Communications Act 2003:
 - b. Behave in a threatening or abusive manner likely to cause a reasonable person to suffer fear or alarm contrary to s.38(1) of the Criminal Justice and Licensing Scotland Act 2010.
- 2. On 21/12/2018, you were convicted at Edinburgh Sheriff Court of the following offence:
 - a. Fail to comply with conditions of bail contrary to the s.27(1)(b) of the Criminal Procedure (Scotland) Act 1995 (Domestic Abuse Aggravator (Scotland)).
- 3. On 10/01/2019, you were convicted at Edinburgh Sheriff Court of the following offences:
 - a. Behave in a threatening or abusive manner likely to cause a reasonable person to suffer fear or alarm contrary to s.38(1) of the Criminal Justice and Licensing Scotland Act 2010;
 - b. Behave in a threatening or abusive manner likely to cause a reasonable person to suffer fear or alarm contrary to s.38(1) of the Criminal Justice and Licensing Scotland Act 2010 (Domestic Abuse Aggravator (Scotland));
 - c. Fail to comply with undertaking contrary to Schedule 1, Paragraph 1(1)(c) of the Criminal Justice (Scotland) Act 2016 (Domestic Abuse Aggravator (Scotland)).
- 4. On 21/10/2022, you were convicted at Edinburgh Sheriff Court of the following offence:
 - a. Careless driving (non-fatal accident) contrary to s.3 of the Road Traffic Act 1988.
- 5. You failed, immediately, to inform the General Dental Council that you were convicted on 27/11/2013, at Edinburgh Sheriff Court of two offences, set out at allegation 1. above.
- You failed, immediately, to inform the General Dental Council that you were convicted on 21/12/2018, at Edinburgh Sheriff Court of one offence, set out at allegation 2, above.

- 7. You failed, immediately, to inform the General Dental Council that you were convicted on 10/01/2019, at Edinburgh Sheriff Court of three offences, set out at allegation 3, above.
- 8. You failed, immediately, to inform the General Dental Council that you were charged with the following offences:
 - a. On 29 Oct 2020, on a road or other public place, you did drive a mechanically propelled vehicle, namely a motor car dangerously, contrary to section 2 of the Road Traffic Act 1988, as amended.
 - b. On 29 Oct 2020, you were concerned in the supplying of a controlled drug, namely Cocaine a Class A drug, to another or others, contrary to Section 4(1) and (3)(b) of the Misuse of Drugs Act 1971;
- 9. Your conduct in relation to allegations 5, 6, 7 and 8 was:
 - a. Misleading and/or
 - b. Dishonest.

AND THAT your fitness to practise is impaired by reason of your Misconduct and/or Conviction."
