CHARGE

LEE-BRIGGS, Floyd Jean-Paul Ramone Amos, a dentist, BDS University of Manchester 2020, is summoned to appear before the Professional Conduct Committee on 21 January 2026 for an inquiry into the following charge:

“That being registered as a dentist:

1. On 30 January 2023, you were convicted before Merseyside Magistrates Court, sitting at Wirral Magistrates Court, of an offence that on 29 January 2023, you used a motor vehicle on a road, or other public place, when there was not in force in relation to that use, a policy of insurance as complied with the requirements of Part VI of the Road Traffic Act 1988, contrary to section 143 of the Road Traffic Act 1988 and Schedule 2 of the Road Traffic Offenders Act 1988.
2. On 3 April 2023, you were convicted before Merseyside Magistrates Court, sitting at Wirral Magistrates Court, of an offence that on 14 June 2022, you drove a motor vehicle on a restricted road, at a speed exceeding 30mph, contrary to section 89(1) of the Road Traffic Regulation Act 1984 and Schedule 2 of the Road Traffic Offenders Act 1988.
3. On 28 April 2023, you were convicted before Greater Manchester Magistrates Court, of an offence that on 25 March 2022, you drove a motor vehicle on a special road, subject to regulations, at a speed exceeding 40mph, contrary to section 17(2) (3) and (4) of the Road Traffic Regulation Act 1984, Schedule 2 of the Road Traffic Offenders Act 1988 and The M62, M602, M6 and M60 Motorway (Manchester Smart Motorway Scheme) (No.2) (Temporary Restriction and Prohibition of Traffic Order 2019).
4. On 28 April 2023, you were convicted before Greater Manchester Magistrates Court, of an offence that on 27 March 2022, you drove a motor vehicle on a restricted road, at a speed exceeding 30mph, contrary to section 89(1) of the Road Traffic Regulation Act 1984 and Schedule 2 of the Road Traffic Offenders Act 1988.
5. On 12 May 2023, you were convicted before Merseyside Magistrates Court, of an offence that on 12 September 2022, you drove a motor vehicle on a restricted road, at a speed exceeding 30mph, contrary to section 89(1) of the Road Traffic Regulation Act 1984 and Schedule 2 of the Road Traffic Offenders Act 1988.
6. You failed to immediately inform the General Dental Council that you have been convicted of the following offences:
 - a. The offence as outlined at 1. above; and/or
 - b. The offence as outlined at 2. above; and/or
 - c. The offence as outlined at 3. above; and/or
 - d. The offence as outlined at 4. above; and/or
 - e. The offence as outlined at 5. above.
7. Your conduct in relation to 6. was:
 - a. Misleading; and/or
 - b. Lacking in Integrity; and / or



c. Dishonest.

AND THAT your fitness to practice is impaired by reason of your conviction(s) and / or misconduct."
