CHARGE

Vinorshan RAVINDRAKUMAR, a dentist, BDS King's College London 2019 is summoned to appear before the Professional Conduct Committee on 3 March 2025 for an inquiry into the following charge:

"That being a registered dentist:

- 1) Between 10th August 2021 and 17th February 2022, you failed to provide an adequate standard of care for the Patient, in that:
 - a) You did not undertake sufficient diagnostic assessment namely:
 - i) Check the Patient's medical history prior to examination; and/or
 - ii) Establish the Patient's medical and social history.
 - b) On 3rd February 2022, you did not refer the Patient by an urgent pathway having:
 - i) Noted that the lesion remained after smoothing treatment to the tooth UR7; and/or
 - ii) Describing the lesion as a 'hard nodule'.
- 2) Between 10th August 2021 and 17th February 2022, you failed to provide sufficient aftercare in that:
 - You did not provide smoking cessation advice on 10th August 2021;
 - ii) Following the smoothing on 20 January 2022 you did not advise to return if the lesion did not resolve; and/or
 - iii) You did not check that the Patient had received the referral for investigation of potential oral cancer.
- 3) Between 10th August 2021 and 17th February 2022, you failed to maintain an adequate standard of record keeping in respect of the Patient's appointments, namely:
 - a) On 10th August 2021, you did not record the Patient's medical history prior to examination as unchanged (or words to that effect);
 - b) You did not record that the Patient was an active or ex-smoker;
 - c) You did not record advice or discussion regarding smoking being a risk factor for periodontal disease and oral cancer;
 - d) On 20th January 2022, you did not record any notes for this session such as initial diagnosis and/or treatment offered for the Patient's lesion;
 - e) On 20th January 2022, you did not record size, location and/or a description of the lesion;

f) On 3rd February 2022, you did not record that you carried out an oral cancer risk assessment as required by the NICE guidelines;

AND THAT your fitness to practise is impaired by reason of your misconduct."
