**CHARGE**

Arthif Knowmahn DANIAL, a dentist, BDS Lond 2008, is summoned to appear before the Professional Conduct Committee on 12 January 2026 for an inquiry into the following charge:

*'That being a registered dentist:*

1. *On a date unknown in or around May 2020 you:*
  - a. *Pulled down Person 1's scrub top*
  - b. *Asked her what the tattoo on her back said, or words to that effect*
  - c. *Said that the font was not right and that the tattoo was back to front, or words to that effect*
2. *Your conduct in respect of paragraph 1 above was:*
  - a. *Inappropriate*
  - b. *Sexually motivated*
3. *Between in or around June 2020 and a date unknown you:*
  - a. *Asked Person 2 whether she had ever had a sexually transmitted disease, or words to that effect*
  - b. *Asked her whether she "used protection", or words to that effect*
  - c. *Asked her what her views were on one night stands, or words to that effect*
  - d. *Asked her how many people she had "slept with" or words to that effect*
  - e. *Asked her whether she had a boyfriend, or words to that effect*
  - f. *Asked her what kind of guys she was into, or words to that effect*
4. *Your conduct in respect of paragraph 3 above was:*
  - a. *Inappropriate*
  - b. *Sexually motivated*
5. *Between in or around June 2020 and a date unknown you:*
  - a. *Made one or more comments about white women being "fair game", or words to that effect*
  - b. *Made one or more comments about white women not having many morals and that they only seek media attention and fame, or words to that effect*
  - c. *Said that you had experienced white women falling at your feet, or words to that effect*
6. *Your comments at paragraph 5 above were:*
  - a. *Inappropriate*
  - b. *Unprofessional*
  - c. *Racially motivated*

*And that in consequence of the matters set out above, your fitness to practise is impaired by reason of your misconduct.'*
